MINOR'S FULL RELEASE BY PARENT/GUARDIAN IN CUSTODY

In consideration of receiving permission from Hunter Street Baptist Church, hereafter referred to as HSBC, an Alabama corporation, by its officers, employees, or designees, to use the climbing wall and rappelling equipment, on its premises, or at an off premises event sponsored by HSBC, the undersigned as the parent/guardian in custody of the minor child hereby releases HSBC, its officers, employees, trustees, and designees of and from any and all liability, claims, demands, actions, and causes of action whatsoever, arising out of or related to any loss, damage or injury, that may be sustained by any of the undersigned.

The undersigned is fully aware of the risks and hazards in participating in any climbing and rappelling activity off the premises of HSBC and with those on the premises of HSBC. The undersigned as the parent/guardian of the minor child hereby elects voluntarily to allow minor child to enter upon the said premises or off premises area to participate in climbing and rappelling activities, and the undersigned further knows his or her own minor child's physical condition and skills as they relate to such potentially hazardous activity. The undersigned as the parent/guardian in custody of the minor child and on behalf of the minor child hereby voluntarily assumes all risks of loss, damage or injury, including death, that may be sustained by the minor child using the climbing wall located at HSBC, or participating in an off premises event sponsored by HSBC.

This release shall be binding upon the minor's heirs, next of kin, executors, and administrators of each of the undersigned.

In signing the foregoing release, each of the undersigned hereby acknowledges and represents:

a) That he or she has read the foregoing release, understands it, and signs it voluntarily; (b) The undersigned individually and as the parent/guardian in custody of the minor child does agree to indemnify and hold harmless HSBC, a corporation, its agents, employees, officers, trustees, and designees from any damage, cost claim, or legal fees by his or her minor child's use of the climbing wall and / or premises or participation in an off premises event sponsored by HSBC; (c) That the undersigned clearly understands the risks and hazards of climbing and rappelling from the structure located on the premises of HSBC or at an off premises event sponsored by HSBC; (d) That the undersigned on behalf of the minor has inspected the climbing area and equipment prior to his or her minor child climbing and has found the area, equipment and accessories in a safe and dependable condition; (e) That the undersigned is the parent/guardian in custody of the minor and represents to HSBC that he or she has the authority to sign this release on behalf of his or her minor child and; (f) That the undersigned has read, understands and agrees that his or her minor child will comply with the rules and regulations attached to this document and posted at the climbing wall.
